The 2022 MSCI Novice State and Open Tournament was one of the first in-person tournaments since the start of the 2020 pandemic. It was held once again at Novi High School with a complete slate of events. The Novice State tournament hosted approximately 160 students with the open tournament hosting approximately 130 from 25 schools. Professional Development at the Mackinac Spring Conference-2022

Building off the success of the 2021 MSCI Professional Development weekend, the Professional Development at this year's conference was small

but mighty. This year Michigan Speech Coaches offered three unique PD sessions based on member interest.

Former MSCI Executive Board member Chris Kuhlman presented an in-depth look at speech activities with his critique and constructive criticism section. Kuhlman's morning session was titled "Constructive Critiques: Providing Ballots That Make A Difference" and those in attendance shared ideas in a round-table discussion that is sure to benefit the community at large. Chris and the group talked about ways to continue to better the community with criticism that enriches the lives of the students who participate in speech activities.

The second session was titled "Beyond High School: Preparing Students for a Future in Speech" and was run by Ryan Rigda (Saginaw Valley State University) & Carole Bennett (Oakland Community College). The purpose of this session was to reintroduce what offerings are available to students who may wish to continue speech activities beyond high school. The session provided wonderful resources and contact information to all those in attendance. Finally, three MSCI members (Sarah Scurti, Karah Tanski & Jen Leija) led a session titled "Cultural Responsiveness and Equitable Judging Practices (Part Two)" – part two because it was a continuation of a popular session led during the 2021 MSCI Professional Development weekend.

The workshop focused on culturally responsive and inclusive judging practices for all coaches and judges who participate in speech activities. The largely informational session was a big hit amongst those in attendance and the session leaders even stayed late to answer questions afterwards.

Professional Development is only one part of the MSCI Spring Conference experience providing members to engage and interact in speech activity discussions to learn and grow as professionals. Thank You from DUDL

Thanks to the Executive Board and Membership of the Michigan Speech Coaches, Inc. (MSCI), MSCI has generously contributed at least \$500 per year to the Detroit Urban Debate League to sponsor awards and trophies for our many tournaments. The DUDL sponsors a minimum of six tournaments per year for which awards are needed. This academic year (2019-2020), we sponsored eight events, including a kickoff event at the downtown Detroit law firm of Dykema Gossett, and the Junior Varsity State tournament at Al Furqan Academy in West Detroit. The DUDL sponsors competition in Varsity or Open, Junior Varsity and Novice Policy Debate. It also holds monthly tournaments for middle school public forum debate

The League also administers a weeklong summer institute in August, which culminates in a mini-tournament for policy and public forum debaters.

All of these events are facilitated by the motivational impact of trophies subsidized by the MSCI.

2022 Hall of Fame Inductees

MSCI is tremendously excited to honor the newest inductees to the Hall of Fame. These two coaches are important not only to this organization, but to all students in the State of Michigan who take part in speech activities.



Beth Campbell is a teacher, advisor, director, and coach at Alma High School in Alma, Michigan.Beth was the theater director/advisor for 21 years, and has coached Individual Events for 19 years. The IE team has won over 50 team trophies – earned when a team finishes in the top three at a tournament – 3 Tri-Valley Conference championships, and has had over 20 state semifinalists and six state finalists.

She has also served her community as Forensic/Drama, Spanish, and Humanities teacher, the Alma Education Association President, the Pine River Arts Council President, and the Lucky MacDuck Day Coordinator.

When talking about her induction Mrs. Campbell stated, "this recognition was a complete shock to me. When he (President Doug Bevier) told me I had been nominated and selected for the Hall of Fame, I couldn't even speak for a minute. I said, 'But Doug, I run such a tiny program!' His response was that sometimes it is tougher to keep a smaller program running, particularly for so long. Bigger teams in more urban areas have alumni to help with funding, siblings who compete and will encourage others to do so, even private performance classes and more advanced speech programs. Another coach said to me last weekend that it's the coaches who show up every day and just keep doing the job who are the

heroes. I don't necessarily feel that way about myself, but I can accept that I have worked hard and had some success in my tenure as a coach."

She went on to say that "speech activities offer students a unique opportunity that builds critical skills for their present and future. Students learn how to see multiple points of view, how to determine the credibility of information, and how to speak their opinions with integrity, confidence, and kindness. These skills have become more and more rare, and for students who have spent countless hours interacting with a screen, it is vital that they learn to look at other human beings and converse effectively. Sports and other academic clubs provide some, but not all, of these merits. I am so proud to be part of a professional community of teachers and other speech coaches who care so deeply about helping young adults find their authentic voice and a forum for expression. The affirmation and acceptance they find in forensics changes—and saves—lives."



Dan Jacobs is a teacher and coach at The Roeper School in Birmingham, MI. This year marks Mr. Jacobs' 30th year of coaching. He began as an assistant coach in Plymouth for two years. Jacobs then worked at Seaholm High School for three years before moving to The Roeper School, where he has held his position for the last 25 years.

When talking about his induction Mr. Jacobs stated that "my friends and peers in forensics have always felt like a home to me. Having some time to reflect with them on the time and mutual experiences leading up to this recognition has given me a solid touchstone for everything we've created together in over 30 years of providing spaces where kids' voices can be heard. It's rewarding to watch some of these folks grow from 11-year-olds into coaches in their own right -- and to feel the growth inside myself from being immersed in a seemingly endless process of creativity and discovery." He went on to say, "forensics and debate give students the ideal low-stakes spaces for trying on a variety of viewpoints and exploring different ways to articulate what they're most passionate

about. I have yet to find a better venue for inspiring self-motivated learning where students feel the intrinsic value of critical thinking and self-expression."

Ryan Nierman has been coaching Groves Debate since he graduated from the program in 2007. Though it has required balancing it with attending college, earning a PhD, becoming a father, and full time work outside of education, Ryan has always been committed to Groves Debate and believed in the educational value of competitive debate. Ryan commented, "I have coached huge teams and small teams, and regardless of how many students are on the team, it's always a thrill to see who rises to the challenge at the State tournament. This

This was our sixth varsity state title of my coaching career, and seeing the novices finish second bodes well for the future of this program." I am happy to spend my time prepping, coaching, traveling and supporting debate because I believe all students are well served by competing in debate regardless of their level of success, but winning is always more fun."

Chris Kuhlman, forensic coach at the Gene L. Klida Utica Academy for International Studies coached the team to Class C/D second place finish was a huge success for UAIS. Mr. Kuhlman has been coaching for thirteen years: this year marks nineteen years of teaching for Mr. Kuhlman. He stated, "I am honored to be recognized by a committed group of educators who help students find their voices and encourage them to use it in advocacy of their truths and their passions. We need more speech activity recognition, support, and advocacy in all levels of education. It should be every district's goal to empower student voices and actively find ways to provide educational opportunities to use them. I would also like to add that this recognition is as much about the students as it is about anything else. They are a tenacious group of open-minded individuals who are willing to accept critique, correction, and revise to make their pieces grow. From the start of the season to the end, they never stopped working and looking for avenues to improve. It is a privilege to

work with such an inspiring group of individuals."

John W. Rutherford has been a theatre teacher for over 30 years, spending the last 22 at Groves High School. This past year he coached his students to be Studio-Division 1 champions with their production of Bystander 9/11. Mr. Rutherford said, "theatre became an integral part of my life when I was in 7th grade. These past 40 years I have not gone a year without having theatre take up part of my time and energy. I simply cannot stop!" He went on to say, "I am so inspired by my fellow colleagues. The teachers, coaches, and directors I encounter at festivals and competitions amaze me. Each of us is doing what I feel is the most important thing, giving back to others. When we share our love and passion for what we do, whether it be theatre, forensic or debate, we are providing lifelong memories that can inspire the next gen to work to their fullest. In the end, theatre is all about storytelling, and I love to tell stories."
